

Directions to Tallinn, to the Conference venue and to the Conference hotel

Getting to the Conference Hotel from the airport:

By bus: Conference delegates can take a bus nr 2 straight from the north entrance of the airport and ride to the stop called "Kaubamaja". From there you walk 7 min to the hotel. The ride takes approximately 22 minutes and costs only a few euros. You can buy the bus ticket straight from the bus.

By Taxi Taking a taxi is also a good option They take about 15 minutes to reach the hotel and cost approximately 8-10 euros.


